### ORDER

The court has considered this application and the *Declaration in Support of Application for Order for Publication of Summons*, and orders as follows:

1. ☐ The court finds that the respondent cannot with reasonable diligence be served in another manner as specified by the Code of Civil Procedure sections 415.10 through 415.50 and that a cause of action exists against the respondent.

THEREFORE, IT IS ORDERED that service of summons on the respondent in this action be made by publication in the newspaper named in this Application and Order for Publication of Summons, a newspaper of general circulation hereby designated as the newspaper most likely to give notice to the respondent, and that publication be made at least once a week for four consecutive weeks. Petitioner shall file proof with the court that the publication has taken place within 30 days after the publication period has ended.
