I understand that proof of my completing traffic school is due on _____ and that no extensions will be granted on the traffic school completion date.

I understand that if I do not make a payment each due date, I may be charged with a misdemeanor under Vehicle Code section 40508, be charge up to \$300 under Penal Code section 1214.1 or have a warrant issue for my arrest, and the court may impound my driver's license and report convictions to the Department of Motor Vehicles. The court also may assign my case to a collection agency to the State Franchise Tax Board for collection.

I understand that my case will continue to be open until the date that my last installment is paid. On _____, if I pay as agreed and if my original certificate of traffic school completion is filed with the clerk, my eligible violations will be dismissed and no further proceedings will be held.

ADVISEMENT OF RIGHTS

By choosing to pay traffic violator school fees in installments and not go into court, you will be giving up these rights:

- ⚡ To appear in court for formal arraignment, plea and sentencing;
- ⚡ To have a court trial and challenge the charges;
- ⚡ To have a speedy court trial and have the charges dismissed if a speedy trial is requested but not provided;
- ⚡ To be represented by an attorney at your expense;
- ⚡ To subpoena or present witnesses and physical evidence using the power of the court at no cost to you and to testify on your own behalf;
- ⚡ To confront and cross-examine all witnesses testifying under oath against you, and
- ⚡ To remain silent and not testify.

Approved Traffic Schools

To obtain a list of approved traffic schools, visit the Court's website at www.riverside.courts.ca.gov. From the home page click on the 'Traffic' button, and then click on the 'Traffic School' link. There you will find a listing of approved traffic schools recognized by the DMV and a listing of additional traffic schools and home study courses approved by Riverside County.

INSTRUCTION SHEET FOR COMPLETING THE AGREEMENT TO PAY TRAFFIC SCHOOL FEES INSTALLMENT PAYMENTS FORM

An Agreement To Pay Traffic School Fees In Installment form is required if you elect to make payments on violation(s) which are eligible for traffic school dismissal and that do not require a mandatory appearance.

Instructions for Completing the Form:

NOTE: If the court mailed you this form, some of the information may already be pre-printed for you.

1. Read pages 1 and 2 of the Agreement To Pay Traffic School Fees In Installments form.
IMPORTANT: Page 2 is the advisement of your rights.
2. Fill-in your name next to 'DEFENDANT' in the heading.
3. Fill-in your Citation Number. This is the pre-printed number on the upper right-hand corner and/or the lower right-hand corner of your citation. Please include all number and letters that appear.
4. In #1, list the infraction violation(s) that you want to attend traffic school on. For example, you were cited for Exceeding the Maximum Speed (VC 22349B) and No Evidence of Current Registration (VC 4000(a)(1)). You would list the violation on the form as follows:

a. § VC 22349B

You will only list the violation(s) that are eligible for dismissal based on completing traffic school.

5. Sign, date and print your name, address, Driver's License number and phone number at the bottom of the form.
6. You may return the completed form to the court location listed at the bottom of your citation. If you chose to mail, the form can be mailed to one of the following addresses:

7. Failure to deliver the completed form, make an appearance, or pay in full on or before your appearance date may result in a civil assessment of \$300.00 being imposed under Penal Code section 1214.1, a vehicle license hold, or wage garnishment.
