CERTIFICATE OF AUTHORITY APPLICATION FOREIGN LIMITED LIABILITY COMPANY

No foreign business limited liability company, and no foreign professional limited liability company, may transact business, or render professional services, in North Dakota, <u>or</u> obtain any license or permit required by North Dakota law, until a certificate of authority has been obtained from the Secretary of State. An application for certificate of authority must be accompanied by a <u>current CERTIFICATE OF GOOD STANDING or CERTIFICATE OF EXISTENCE</u>. The Certificate of Good Standing or Certificate of Existence must have been certified within 90 days by the organizing officer of the state or country in which the limited liability company must also be accompanied by a certificate from the North Dakota licensing board for that profession, verifying that the practitioners of the limited liability company have been licensed to provide the professional service.

Instructions: The following numbered instructions correspond to the numbers on the form.

- 1. Check all the attachments applicable to this application. Those items preceded by an * are required for all applications. <u>All forms must be received and all fees must be paid before the certificate of authority can be issued</u>.
 - FILING FEES: Certificate of Authority \$135 Consent to Use Business Name \$10 Trade Name Registration \$25

(Checks must be payable to "Secretary of State" and must be for U.S. negotiable funds. Payment may also be made by credit card using VISA, MasterCard, or Discover.)

- 2. Indicate whether the application is being submitted for a Certificate of Authority for a foreign business limited liability company or a foreign professional limited liability company.
- 3. While the federal ID number is not required to be disclosed, a limited liability company's Federal ID number is helpful for maintaining accurate records. Please provide, if you have one.

PRIVACY: In compliance with N.D.C.C. Section 10-32.1-95, social security or Federal ID numbers are not disclosed to the public. They are used by the Secretary of State to maintain accurate limited liability company files. Therefore, while voluntary disclosure is requested, failure to do so will not result in rejection of the application.

- 4. Provide the correct name as authorized in the state or country of organization. Punctuation and abbreviations must be consistent with those in the name on the certificate from the organizing officer of the state or country where organized. If the name in number 4 is not the same as reflected on the Certificate of Good Standing or Certificate of Existence, the name will be corrected by the Secretary of State when the document is reviewed.
- 5. Provide the trade name and the Trade Name Registration form with \$25 if the limited liability company cannot use its name because:
 - a) The limited liability company name is not in the form as required of a limited liability company in North Dakota. The name must be expressed in letters or characters in the English language as those letters or characters appear in the American Standard Code for Information Interchange (ASCII) table. The name must include the words "limited liability company" or the abbreviation "L.L.C." or "LLC". If a foreign limited liability company name does not contain these words or one of the abbreviations, the limited liability company must elect one to be used in North Dakota. The application cannot be accepted if an election is not made and the limited liability company name in number 6 is not in compliance with this requirement.
 - b) The name of a foreign professional limited liability company shall contain words or abbreviations required or authorized by the laws of the jurisdiction in which it is organized. (For reference, see N.D.C.C. Sections 10-32.1-73 or 10-31-05.)
 - c) The North Dakota Secretary of State has notified the limited liability company that its amended name is the same as or deceptively similar to a name already registered and the limited liability company is unable to obtain Consent to Use Business Name from the previous filer or a certified copy of a final decree of a court of competent jurisdiction establishing prior right of this limited liability company to use of the amended name in North Dakota.

North Dakota law provides that a limited liability company name may not be the same as, or deceptively similar to, a name previously registered with the Secretary of State. The name may be used if the limited liability company obtains a court decree or signed Consent to Use Business Name that is submitted with a fee of \$10. Obtain the form from the Secretary of State's website at www.nd.gov/sos or contact the Secretary of State. If Consent to Use Businest, a trade name (DBA) must be elected.

d) The limited liability company does not wish to use or protect its amended name in North Dakota and chooses to use a trade name instead.

TRADE NAMES: A limited liability company may choose to use any trade name (DBA) in addition to its limited liability company name in North Dakota. The trade name must be registered with the Secretary of State. However, the trade name should not be provided in number 7, except as described above. Instead, complete and attach the Trade Name Registration and fee of \$25 for each assumed name. Obtain the form from the Secretary of State's website at sos.nd.gov or contact the Secretary of State.

- 6. A complete address of the limited liability company's principal executive office is required. A complete address must include a street or rural address, a post office box (if applicable), the city, state, and ZIP code plus 4-digit extension. The address cannot only be a post office box number.
- 7. Identify the state or country in which the limited liability company is organized. If the state or country of origin in number 7. is not the same as reflected on the Certificate of Good Standing or Certificate of Existence, the state or country will be corrected by the Secretary of State when the document is reviewed.
- 8. Provide the date (month, day, year) on which the limited liability company will expire in the state or county of origin or <u>check the "Perpetual" box if a</u> termination date is not prescribed in the Articles of Organization.
- 9. The telephone number of the limited liability company's principal executive office is required.
- 10. Provide a toll-free telephone number if the limited liability company has one.

11. A foreign limited liability company must continuously maintain a commercial or noncommercial registered agent and address in North Dakota. A foreign limited liability company cannot serve itself as its registered agent. The registered agent receives all legal notices for the limited liability company, including service of process against the limited liability company. The registered agent is expected to forward all notices to the limited liability company.

A <u>commercial registered agent</u> must be registered as a commercial registered agent with the North Dakota Secretary of State. The appointed agent can verify their status as a commercial registered agent from their acknowledged filing and from the list of commercial registered agents maintained on the Secretary of State's website at sos.nd.gov.

A noncommercial registered agent may be one of the following:

- a) An individual residing in North Dakota;
- b) A domestic or foreign corporation; or
- c) A domestic or foreign limited liability company.

A corporation or limited liability company appointed as a noncommercial registered agent <u>must be registered with the Secretary of State, be in good</u> <u>standing, and have a business address in North Dakota</u>. If a corporation or limited liability company is named as a noncommercial registered agent, provide the "correct" name of the organization.

Seek the approval of the party before naming them as the commercial or noncommercial registered agent. Proof of the approval is not required to be filed with the Secretary of State. Failure to seek consent from the party named as agent may result in revocation of the LLC's certificate of authority.

- 11A. If a commercial registered agent is being appointed, provide the correct name as registered with the North Dakota Secretary of State. If the name in number 11A is not the same as registered by the commercial registered agent, or is incorrectly provided in 11B, the name will be corrected by the Secretary of State when the document is reviewed. **OR**
- 11B. If a noncommercial registered agent is being appointed, provide the correct name. If a corporation or another limited liability company is appointed as registered agent and the name of that organization in number 11B is not the same as registered, or is incorrectly provided in 11A, the name will be corrected by the Secretary of State when the document is reviewed.
- 11C. If a noncommercial registered agent is being appointed, provide the complete address in North Dakota which may not be only a post office box. Leave this line blank if a commercial registered agent is appointed. If a commercial registered agent is named in 11A and an address is provided in 11C, the address will be removed by the Secretary of State.
- 12. Describe the business activities or professional services which the limited liability company conducts or intends to conduct in North Dakota.
- 13. List the names and complete addresses of the managers and governors. A foreign professional limited liability company must list all members and managers who practice the profession in North Dakota. If the space provided is not adequate, attach a list of additional managers and governors.
- 14. The application must be signed and dated by a person authorized to sign on behalf of the limited liability company.
- 15. Provide the name, email address, daytime telephone number, and extension, if any, of a contact person if this office has any questions or needs additional information. The email address is not disclosed to the public; this information is privatized in accordance with N.D.C.C. Section 44-04-18.21.
